### **Terms & conditions of sale.**

#### ***Context***

The web site [www.kdpresse.com](http://www.kdpresse.com) is not a virtual newsagent. The site allows press publishers to offer in France and overseas on-line subscriptions with secure payment.

KD acts as the sales agent for the press publishers.

The publishers who offer this facility are fully aware of the general sales conditions.

The customer is solely responsible for the choice of magazine and the rate offered at the time of subscription.

#### ***Sales offer and payment***

The tariff displayed includes all taxes, postage and packaging.

The payment system uses the SSL norm and may be used with the following bank cards; Mastercard, Eurocard, VISA and Carte Bleue.

All payments and debits are made in Euros (€).

The publishers reserve the right to modify at any moment and without warning, through KD, their subscription offer.

#### ***Rights & responsibility for the products***

As a sales agent, KD may not be held responsible for the following incidents: change in the rhythm of publishing and the temporary or permanent stopping of the publishing of an item.

In accordance with article L. 121-20-2 paragraph 5 of the consumer protection law (law. n° 2001-741 of 23rd August 2001 article. 5, article. 12, JO 25th August 2001), the right of withdrawal may not be used, except if the parties have made alternative arrangements, regarding the supply of newspapers, periodicals or magazines.

#### ***Postage and packaging***

As the sales agent, KD may organize the delivery of the magazines, on behalf of the publishers.

The customer is fully responsible for the correct input of the data that will be used for the delivery of his magazine. Complaints or refunds shall not be entertained in the case of incorrect or in-complete data input during the subscription process. Where it is necessary to modify data the customer should contact the subscription department by e-mail at either of the

The postage charges for Europe and the rest of the world are included in the tariffs displayed. They also take into account the type and weight of the package.

The customer is entirely responsible for his purchase/subscription vis-à-vis the legislation currently in vigour in the country where the purchase was made.

The customer is fully responsible for the delivery of his order. He recognizes that he is fully informed on the legislation currently in force in his country before his purchase/subscription of the magazine on the Internet.

All orders carried out on the site and delivered outside France may be subject taxes & customs duties when the package arrives at its destination. These customs duties and taxes associated with the delivery are at the charge of the subscriber. KD is not bound to inform the subscribers of the customs duties and taxes applicable outside France.

KD may not be held responsible should the services be interrupted by a partial or complete strike of the postage sorting depots or any other way the post is sent.
